MINUTES OF THE MEETING

All members of the Education Committee were present except Drs. McGuire and Tidd.

1. The minutes of the meeting of February 5, 1959 were accepted as distributed.
2. Admissions Committee: The Admissions Committee recommended the following:
 - (a) Dr. Remo DiCenso's application for training was rejected.
 - (b) Dr. William Dunlop will be informed that he should undertake an effective piece of therapeutic psychoanalysis and he then might reapply.
 - (c) Dr. Bernice Ennis will be informed that she should continue her therapeutic psychoanalysis and might consider reapplying in the future.
3. Candidates:
 - (a) Dr. Marvin Berenson's request for a second unsupervised case was approved.
 - (b) Dr. James Mott's request for a third case under supervision was approved.
 - (c) Dr. Greenson reported on the meeting with the candidates which essentially concerned the Psychoanalytic Clinic. Some candidates felt they would prefer having some flexibility as to the time of taking their Clinic case. They also thought the fees might accrue to the candidate after 300 hours. These ideas were submitted to Dr. Brunswick who will take them under advisement.
 - (d) Dr. Maimon Leavitt's request for graduation was approved. There was unanimous agreement that the caliber of his work and his personal characteristics were of a high order.

(e) There was some discussion about the work of Dr. James Grotstein and it was the consensus that he showed definite improvement although a tendency toward clowning still exists.

4. Training Analysts:

(a) Dr. Hanna Fenichel reported that she was unable to express a definite opinion about the readiness of Dr. Samuel Futterman to be considered for appointment as Training Analyst. The Education Committee agreed that Dr. Futterman should have the opportunity of presenting one of his cases under supervision to another supervising analyst. Dr. Greenson was chosen for this assignment.

(b) There was further discussion about the procedures for reappointment of Training Analysts. There seemed to be agreement that at such a meeting Training Analysts should be permitted to vote by proxy. Furthermore, it was suggested that a minimum of two meetings be held so that in one meeting the member under discussion would be absent and in a second meeting, he would be present if there were any doubt about his reappointment. Furthermore, a special committee might be appointed for a more thorough investigation of the problem if it were warranted. These formulations will be incorporated in a new memorandum which will be distributed to the Education Committee for further discussion.

(c) It was suggested that in our procedure for the selection of new Training Analysts, provision be made so that more than one supervising analyst might have the opportunity to evaluate the work of the prospective Training Analyst. The Education Committee is to select the supervising analyst for the prospective Training Analyst. This will be re-formulated in a memorandum and submitted to the Education Committee for further discussion.

5. Committees:

(a) The recommendations for the Child Analysis program as submitted by Mrs. Ruben were discussed. The Education Committee members were polled as to the number of prospective candidates who might be ready to take this special training. Since there might be four such candidates, it was decided to circularize the candidates in order to arrive at an accurate estimate of the number of students who might begin such a course in the Fall of 1959. After this has been accomplished, the matter will be brought up before the Education Committee.

(b) The question of a Faculty Committee was postponed due to the lateness of the hour and it was decided to circularize a memorandum explaining the structure and function of this new committee.

6. The application for membership of Mrs. Marjorie Leonard was discussed at considerable length. The Education Committee concluded that the records of her training seemed to indicate that she has fulfilled the minimum standards for lay analysts trained prior to 1938. However, three members of the Education Committee reported that the caliber of her clinical work was below minimum standards; one Training Analyst was of the opinion that the work he had opportunity to observe was barely adequate. The Education Committee decided to send a statement to the Membership Committee of the Los Angeles Psychoanalytic Society which would indicate that her training qualifications seemed to be in order but in their opinion, her clinical work was unsatisfactory and they would not recommend her for membership. The vote on this matter was 11 in favor of this recommendation and one abstention.

7. Board on Professional Standards - APsAA:

(a) Drs. Rangell and Greenson were appointed as Fellows to the Board on Professional Standards, with Dr. McGuire as Alternate if he attends the Annual Meeting.

(b) There was some discussion about the Board of Psychoanalysis on the basis of Dr. Kamm's letter, which expressed serious misgivings in regard to the formation of such a Board. The Education Committee is also aware of the danger of the formation of a Board but equally aware of the danger of permitting other so-called analysts to form a Board of Psychoanalysis. The Fellows were advised to be vigilant when this matter comes up for discussion at the Annual Meeting.

8. Guest Lecturers:

(a) It was announced that Anna Freud's paper would not be available for reading prior to the meeting.

(b) Dr. George Gero is to be invited to give two lectures to the Los Angeles Society and Institute. He will be invited to come at the end of September. Dr. Stuart Miller will be invited to come in October.

9. New Business:

(a) Mrs. Deri reported that Dr. Marshall Schechter was making satisfactory progress in his analysis and she contemplated an early termination. This was acceptable to the Education Committee.

(b) Dr. Vatz announced that he had begun the personal analysis of Dr. Ronald Mintz.

(c) Dr. Van der Heide suggested that we discuss the pre-seminar candidates at the May meeting in order to ascertain their status.

The meeting was adjourned at 10:20 P.M.

MINUTES OF THE MEETING

All members of the Education Committee were present except Drs. McGuire and Tidd.

1. The minutes of the meeting of January 8, 1959 were accepted as distributed.

2. Admissions Committee:

(a) The Admissions Committee made the following recommendations:

(1) William C. Beckwith, Ph.D. to be accepted for training in research in psychoanalysis.

(2) Stanley W. Bergreen, M.D. to be rejected for training in psychoanalysis.

(3) Hugo del Bosque, M.D. to withdraw his application for training in psychoanalysis.

(4) Jay V. Leopold, M.D. to be accepted for training in psychoanalysis.

(5) Robert Philips, M.D. to withdraw his application for training in psychoanalysis.

These recommendations were approved by the Education Committee. It was announced that Dr. Robert Greuner had withdrawn his application for training.

(b) The Education Committee approved that whenever possible applicants will be informed that an unspecified number of appointments will be arranged for them in order to obviate the necessity for five admissions interviews in grossly unacceptable cases. Every applicant, however, will be assured of a minimum of three interviews.

3. Candidates:

(a) The status of accepted applicants was announced. The Education Committee members were polled as to their expectations in terms of how many new candidates might they begin within the next six months. There are approximately five openings to be expected within the next six months. Our current waiting list contains eight applicants ready to begin within that period. We shall, therefore, inform all applicants that there is a waiting list and perhaps be somewhat more selective in our choices.

(b) Dr. Seymour Bird's request for graduation was approved.

(c) Dr. Leonard Gilman's request for a 3rd supervised case was approved.

(d) Dr. William Horowitz's request for an unsupervised case, his 6th patient, was approved.

(e) Dr. Friedman reported on his meeting in the tax case with the candidates.

(f) Dr. Arthur Ourieff was granted the right to consider that he has fulfilled his Clinic obligation with his Clinic patient, despite the shortage of hours.

(g) It was announced that the individual candidates' records will contain all pertinent information in regard to the candidate's training, plus the reference in the minutes of the Education Committee meeting.

(h) The following announcements were made:

(1) Dr. Richard Migel began personal analysis with Dr. Jack Vatz - 1/26/59.

(2) Dr. Sidney Hulbert completed personal analysis 1/30/59.

(3) Dr. Arthur Malin began supervision with Dr. Friedman - 1/22/59.

(4) Dr. Fred Weaver began personal analysis with Dr. McGuire - 2/2/59.

(i) There was a brief discussion as to whether a candidate in analysis for one month might borrow money from the Candidates Loan Fund. Dr. Vatz will discuss the financial problem with the candidate and Dr. Jokl will work on the problem psychoanalytically with the candidate.

4. Curriculum:

(a) The Education Committee requested further clarification from Mrs. Ruben about the new course in Child Analysis that she would like to begin.

(b) The Education Committee approved Dr. Greenson's request to give a course in Psychoanalytic Technique for advanced candidates as an elective.

(c) The Education Committee approved Dr. Dorn's appointment as an instructor. He will be so informed.

(d) The Education Committee approved the idea of forming a Faculty Committee which would operate as a standing committee of the Education Committee. The exact structure and function will be presented to the Education Committee at the next meeting for finalization.

(e) It was suggested that a special meeting of the candidates should be arranged in which the Dean of the Training School would present to the candidates:

- (1) The change to a 4 year curriculum
- (2) The increase of tuition
- (c) Question about the Psychoanalytic Clinic

(f) Dr. Stuart Miller's guest lectures will be held sometime in the Fall and arrangements for this will be made by the Chairman since these lectures do not coincide with our plans for the curriculum.

(g) Dr. Evans, Chairman of the Curriculum Committee, suggested a list of instructors for the various courses in the Spring Trimester, which were approved by the Education Committee. These were as follows:

(h) Dr. Evans reported that Drs. Brandchaft and Shiell had attended some of his seminars on Freud's Literature. It was discussed in the Education Committee and decided that it would be a good idea when a prospective instructor listens in on a course that he be given an opportunity to teach the course for one session in the presence of the regular instructor. Dr. Rangell agreed to make this arrangement in his next seminar.

5. Guest Lecturers:

(a) The Anna Freud Lectures were discussed with the following results:

(1) The tentative schedule was distributed to the Education Committee members.

(2) Wives of members will be permitted to attend the lecture on "Research in Psychoanalysis".

(3) Dr. Heiman Van Dam was approved for presenting the psychoanalysis of a child case at the Clinical Conference in which Anna Freud will be the moderator.

(4) The Education Committee agreed that either Dr. Leo Rangell or Dr. Hanna Fenichel would be selected to open the discussion of Anna Freud's presentation "The Nature of the Therapeutic Process". Hanna Fenichel requested a delay of a few days in order to consider the situation and then withdrew. Dr. Leo Rangell will be the discussant of the Anna Freud paper.

(5) It was announced that the Child Psychiatric Group and the Psychiatric Social Workers will not be scheduled for Anna Freud.

(6) Dr. Friedman announced the plans for the reception to be held on Sunday, March 29th.

(b) The Education Committee approved of inviting Dr. George Gero to be a guest lecturer some time in the Fall of 1959. The Chairman of the Education Committee will write to him and invite him.

6. Dr. Brunswick briefly summarized the Psychoanalytic Clinic meeting. It was suggested that we might consider asking the Chairman of the Candidates Committee to be a member of the Clinic Committee. Dr. Brunswick has taken the matter under advisement.

7. Membership Committee - APsaa:

(a) The Dean reported on his discussion with Dr. Ruth Barnard in reference to her deferral by the American Psychoanalytic Association.

(b) A letter was read regarding Dr. Henry Luster from the Membership Committee.

8. There was no report from the Board of Trustees since there was available a written report of the proceedings of that meeting. All Education Committee members who have not received a copy of these minutes may call upon Mrs. Yerkes if they are interested in this information.

9. It was felt that the Pairing-Off meeting should occur more frequently in order that we may finish our discussion of the candidates. It was felt by some instructors that the 2nd year students were not as industrious as other classes have been.

10. Training Analysts:

(a) A proposed procedure for the reappointment of Training Analysts was distributed to the members of the Education Committee for their consideration. This will be discussed at the next EC meeting.

(b) It was decided by the Education Committee that a fee should be charged for the supervision of a prospective Training Analyst. This should be a policy of the Education Committee, the exact fee to be determined by the individuals involved.

11. New Business:

(a) Dr. Jack Vatz suggested that all Education Committee members read the Survey Progress Report.

(b) Dr. Van der Hoide suggested that all Training Analysts who have candidates they would like discussed at the Education Committee meetings to inform Mrs. Yerkes of the name of the candidate so that these names can be put on the agenda under the heading of "Discussion of Candidates".

The meeting was adjourned at 10:05 P.M.
