- . The following corrections to the minutes were made:

 - Item 9(a) Correct 2nd sentence to read: "The Education Committee finally decided that Dr. Jack Vatz and Dr. Samuel Futterman shall be informed that the Education Committee is interested in the possibility of appointing them to training analyst status." (Dr. Brunswick)

2. Admissions Committee:

- (a) It was announced that Dr. James A. McCowin had withdrawn his application after one interview because he had been accepted by the Institute for Psychoanalytic Medicine of Southern California.
- (b) The Admissions Committee discussed the application of Dr. Helen Wolff in the presence of the entire Education Committee. Since there was diversity of opinion about her suitability for admission, it was decided that she be asked to have two additional interviews with the two women members of the Education Committee. Her application will then be reconsidered.
- (c) A letter was read from Dr. Joaquin Fuster stating he wished to postpone his formal application for training until he has received information concerning citizenship requirements for a fellowship. This was accepted.

3. Candidates:

(a) Dr. Futterman will be informed to proceed with plans for termination of Dr. Horenstein's analysis when he feels this is advisable as though the possibility of training analyst status were not being considered for Dr. Futterman.

- (b) Dr. Malin's request for a 3rd case under supervision was accepted, and he will contact Dr. Kandelin for a Clinic case.
- (c) Action on Dr. Rubin's request for graduation was postponed since his personal analyst, Dr. Fenichel, was absent from the Education Committee meeting.
- (d) The Faculty and Pairing-Off Meeting has been tentatively scheduled for Thursday, January 29, 1959 at Dr. Greenson's home.

Guest Lecturers:

- (a) Dr. Stuart Miller has accepted an invitation to give a series of three lectures on Metapsychology, and asked if a June date would be acceptable. It was decided that Dr. Miller should be asked to come in the Fall of 1959 as our first choice, and June as a second choice.
- (b) Anna Freud has accepted the time schedule proposed by Dr. Greenson. She will give two formal presentations, which will be open to all candidates and Society members plus special invited guests. Clinical presentations will be limited to candidates and members. For the two clinical presentations, the Education Committee prefers one to be a case presentation of a child and one case presentation of an adult. Details will be worked out with Dr. Nierenberg. Dr. Greenson was authorized to ask a recent graduate to present a case for our Institute.
- The Education Committee discussed some general principles concerning what proceedings should be considered confidential and what does not necessarily have to be kept confidential. All information which is to be given to all candidates need not be considered confidential. All administrative procedures concerning the progress of a candidate's training may be given unofficially by the personal analyst of the candidate directly to the candidate prior to the official notification by the Education Committee. All matters occurring in the various subcommittees of the Education Committee shall be open for discussion to all the members of the Education Committee. The minutes of the Education Committee meetings must be kept confidential from the rest of the Psychoanalytic Society.

6. Training Analysts:

(a) It was announced that Dr. Vatz has started supervision with Dr. Brunswick and Dr. Futterman with Dr. Fenichel. It was again reaffirmed that undertaking of a supervision for purposes of becoming a training analyst means to undergo a period of supervisory hours to last a sufficient period of time in order for the supervisor to come to a decision as to the competence of the psychoanalyst under consideration.

- (b) The Education Committee discussed procedures for appointment to training analyst. The following steps have been confirmed.
- (1) The prospective training analyst will be asked to present a current case in psychoanalytic therapy to a training analyst under supervision. This shall be continued at regular intervals and for a sufficient period of time to insure that the training analyst supervisor has been able to reach a clearcut decision as to the competence of the psychoanalyst being considered.
- (2) It may be required that in addition, the prospective training analyst may be asked to present some clinical material to the Education Committee as a whole. This requirement is optional and at the discretion of the Education Committee.
- (3) Voting on the appointment to training analyst will be done by secret ballot. It will require a 3/4 vote of all the training analysts present to elect a psychoanalyst as training analyst. There must be at least 3/4 of the members of the Education Committee present at such a meeting. The initial appointment shall be for three years.

There was some discussion about the policy concerning reappointment. There was some question about our current procedure of reappointments every 5 years and voting openly and in the presence of those who are under consideration for reappointment. It was felt by some that appointments should be made for as long as an analyst is considered competent. Only then should a subcommittee of the Education Committee investigate questions of competence. There were misgivings, however, expressed by others who felt this amounts to a lifetime appointment. This matter will be discussed again at the next Education Committee meeting. Members were asked to submit their ideas on this matter to Dr. Greenson so that they may be compiled before the next meeting.

(c) Dr. Brunswick and Dr. Lewy felt we should reopen the question of further consideration for appointment to the status of training analyst. This will be put on the agenda for the next meeting.

7. Administrative:

- (a) There was some discussion, and it was recommended, that we increase the application fee from \$50 to \$75 or \$100. The Survey Committee will be asked for information from other Institutes on this matter.
- (b) There was some discussion, and it was recommended, that the tuition fee be increased from the present \$3.33 per unit to \$4 or \$5 per unit. Both recommendations will be referred to the Professional Committee for action.

Report of the Midwinter Meeting:

Dr. Greenson gave a brief report on the significant developments from the Midwinter meetings of the Board on Professional Standards. Dr. Van der Heide supplemented this report.

- (a) An Accreditation Board, under the chairmanship of Bernard Bandler, has been established once more. Drs. Enelow and Lihn from Los Angeles were elected to membership in the American. The Committee on Standards have changed the By-Laws to state that a candidate has to carry one case through the terminal phase, not just to termination. The income tax exemption case was decided against the position of the Los Angeles Society and Institute. There will be no action by the Board on Professional Standards to alter the current situation.
- (b) There was a brief report by Drs. Greenson and Van der Heide on the Survey Committee findings which will be presented in detail to the Los Angeles Society.

New Business:

- (a) Dr. Kupper read a letter in which Camarillo State Hospital would like members of our Institute and Society to participate in their residency training program. He was empowered to utilize the various functions of the Extension Division to help in this matter.
- (b) Dr. Brunswick suggested that on some future agenda we re-examine the question of Dr. Wexler teaching a course on the psychoses to the candidates of the Los Angeles Institute.

The meeting was adjourned at 10:20 P.M.

.l members of the Education Committee were present except Dr. Tidd.

The minutes of the previous meeting were accepted as distributed.

Admissions Committee:

- (a) The Admissions Committee recommended the acceptance for training in psychoanalysis for Dr. Morton Shane and Dr. Simon Horenstein. The Committee recommended that the applications of Drs. Herman Feifel and Nathaniel Showstack be rejected. The Education Committee confirmed these recommendations.
- (b) There was some discussion about the request of Dr. Joaquin Fuster for training in psychoanalysis as a research applicant. The problem is complicated because Dr. Fuster is an M.D. who does not intend to devote himself to private practice but rather to teaching and research. The Education Committee decided that he will be interviewed by the Admissions Committee and it will then decide, if he is acceptable, what form of training he should apply for.
- (c) The Education Committee authorized the Chairman to decide in special cases of obvious sub-standard qualifications to limit the interviews to a minimum of two or more. This would obviate the necessity for five interviews for obviously and flagrantly unsuitable applicants.

Candidates:

- (a) Dr. Evans reported on the fine performance of Dr. Spitzer in Colloquium II. He will be informed he has completed his training.
- (b) Dr. Greenson reported on his discussion re the status of Dr. Furniss, who is now waiting to resume personal analysis with a male analyst.
- (c) The request of Dr. Schechter to resume personal anlaysis was approved and he has made arrangements to begin with Mrs. Deri.
- (d) Dr. Hellinger began personal analysis with Dr. Van der Heide. Dr. Gold began personal analysis with Dr. Jokl.
- (e) Dr. Bird began supervision with Dr. Greenson; Dr. Stewart began supervision with Mrs. Deri; Dr. Perry began supervision with Dr. Jokl.

- (e) Dr. Bail's request for Colloquium II will be deferred since is has not completed the requirement of 200 hours of supervision. In addition, it was felt that he would benefit by delaying Colloquium II until the Spring.
- (f) In the future, when candidates apply for Colloquium II, they will be asked to report about their unsupervised cases in a manner which will be determined by the Education Committee in each individual case. Graduates shall be informed that in order to meet the requirements of the American Psychoanalytic Association, they should bring in a case which is terminating for supervision during this phase.

Le Curriculum:

- (a) The Education Committee decided since there were less than three candidates ready to begin first year courses not to give the first year of the new curriculum until September, 1959. This will become a general policy and the candidates will be so informed. All pre-seminar candidates will be asked to take the course on "The Normal Development of the Child", which is to be given by Dr. Ekstein beginning in January, 1959.
- (b) Dr. Evans discussed the assignment of courses for the second and third year students for the Winter Trimester. These are as follows:

(c) The Education Committee authorized the Curriculum Committee to arrange for the new curriculum to cover a four year period.

(d) The Education Committee felt it was advisable to have a Faculty meeting and a Pairing-Off meeting to discuss candidates in the near future.

5. Board on Professional Standards:

- (a) Since there is no known agenda for the Board on Professional Standards, there were no instructions to be given to Drs. Van der Heide and Greenson, Fellows to the Board.
- (b) There was some discussion as to the advisability of requesting permission for Dr. Wexler to teach in the Institute. This was decided in the negative.

6. Guest Lecturer:

(a) A letter was read from Dr. Stuart Miller, who informs the Institute that although he has been a student of psychoanalytic theory for twelve years, he has as yet not completed his formal training in psychoanalysis. It was decided that this should in no way become an obstacle to our invitation, in fact, the Education Committee feels more than ever that our choice was a good one.

7. Administrative:

- (a) Several complimentary letters were read from the Survey Committee in response to the Manual for Psychoanalytic Candidates.
- (b) Other items on the agenda concerning administrative matters had to be postponed due to the lateness of the hour.
- 8. It was decided that although the Waelder lecture on "Aggression" contains valuable material, the method of presentation makes it unsuitable for mimeographing. The available copies will be kept on hand for those interested.

9. New Business:

(a) There was a long discussion concerning the qualifications of those eligible for becoming training analysts. The Education Committee finally decided that Dr. Jack Vatz and Dr. Samuel Futterman shall be informed that the Education Committee is interested in appointing them to training analyst status. They will be asked that, in accordance with our policy, they begin supervisory work on a current psychoanalytic case with a supervising analyst of their choice.

(b) There was some preliminary discussion about revision of procedures for appointment of training analysts and procedures for re-appointment of training analysts. Dr. Van der Heide made the motion which was seconded and passed that this matter be postponed until the next meeting so that the various members can give this its due consideration.

. The corrections for the minutes of the meeting of September 11, 1958 are as follows:

Change to read:

Paragraph 8 (a): "Dr. Van der Heide had some suggestions and corrections about which

he will inform Mrs. Yerkes."

Paragraph 8 (d): "Dr. Brunswick moved and it was seconded that Dr. Friedman and Dr.

Rangell were now appointed supervising analysts."

. Admissions Committee:

- (a) Drs. Rangell and McGuire have agreed to accept the appointment to the Admissions Committee after the terms of office of Drs. Friedman and Kupper expire.
- (b) Dr. Richard A. Brunner was accepted as a transfer from the Institute for the Philadelphia ..ssociation for Psychoanalysis. He is to be informed of this and also to be informed that his exact status as a candidate will be left indeterminant for the time being. He will be encouraged to begin psychoanalysis under supervision and after a period of time of observation, it will then be decided what his exact status will be. There is the possibility that he may be required to take Colloquium I and in addition attend seminars and perhaps have some more personal analysis. All of this will be determined after we have had an opportunity to observe Dr. Brunner in his supervisory work.

3. Candidates:

- (a) Reportof Colloquia I: Dr. Fenichel reported that Dr. Ralph M. Obler had com-Colloquium I in a satisfactory manner. Dr. Evans reported that Dr. Donald G. Siegel had completed Colloquium I in a satisfactory manner. Dr. Van der Heide reported that Dr. Genevieve Stewart had completed Colloquium I in a satisfactory manner.
 - Dr. Friedman and Dr. McGuire reported that Dr. Ira M. Carson did not demonstrate adequate knowledge of psychoanalytic technique and therefore suggested that Dr. Carson repeat Colloquium I in the future. There was some discussion as to whether or not the colloquium had been a fair one and the consensus was that indeed it had. Dr. Carson apparently feels mistreated in this matter and it will be suggested to him that he might contact either or both of his examiners or the Chairman of the Education Committee for further information. There was also some discussion as to how Dr. Carson knew the results of his colloquium before he had been officially or unofficially informed of it by any member of the Education Committee.

- (b) Dr. Norman Atkins' request for a second case, unsupervised, was granted.
- (c) Dr. Henry Spitzer's request for Colloquium II was approved and Drs. Greenson and Evans were appointed as examiners.
- (d) Dr. Marvin Berenson's request for permission to do an unsupervised case was approved, despite some hesitation voiced by several of his supervisors. This permission to do one unsupervised case does not automatically confer the right to request further unsupervised cases. He will be informed that there is some uncertainty about his ability to do unsupervised cases and that he should report informally to any of his supervisors whatever difficulties he may encounter.
- (e) Dr. Mark Orfirer's request for permission to withdraw from seminars was approved. In addition to certain emotional difficulties, the possibility of a tubercular lesion was mentioned by Dr. Kupper, his personal analyst.
- (f) Dr. Fenichel discussed the status of Dr. Charles Furniss. Essentially, she stated that this candidate, who has been on inactive status and about whom she had felt very pessimistic as far as his training is concerned, recently has shown definite signs of improvement. Nevertheless, Dr. Fenichel believes she can not successfully complete his psychoanalysis and that he should be given the opportunity to have a second analysis, preferably with a male analyst. After some discussion, this request was granted and Drs. McGuire, Friedman, and Greenson indicated a willingness to undertake such an analysis provided the candidate were able to wait a considerable time. The Education Committee further decided that Dr. Furniss should be kept on inactive status since there is still considerable doubt as to the ultimate outcome and since he apparently works better under inactive status.

4. Curriculum Committee:

- (a) Dr. Evans reported that in approximately 2 weeks the academic curriculum for the rest of this year will be distributed to the Faculty, who will be asked to carefully select those courses they would like to teach during the rest of this academic year. All new courses will have an accompanying bibliography to acquaint the prospective teachers with the material to be covered. It is requested that the Faculty select those courses for teaching with which they are experienced and which they feel best equipped to handle.
- (b) The Education Committee decided that Dr. Rudolf Ekstein, who is to teach "The Normal Development of the Child" is to begin this course as soon as possible. It is estimated that the duration will be anywhere from 12 to 18 sessions and will be left up to his discretion.
- 5. The Manual for Psychoanalytic Candidates was discussed and Dr. McGuire is to read it and return it with his suggestions. The Education Committee approved the mimeographing of the Manual after the corrections from Drs. Brunswick, McGuire and Van der Heide had been considered.

5. Guest Lecturers:

(a) The Education Committee approved of our attempt to contact Dr. Stewart Miller of Stockbridge to give three lectures on "Metapsychology: Early and Intermediate." The Chairman of the Education Committee will contact him in order to arrange exact time and further details.

7. New Business

- (a) Psychoanalytic Clinic: Dr. Brunswick reported upon a discussion with the Executive Committee of the Institute in reference to exceptions for the Clinic case rule. It was decided by the Education Committee that in the future, there will be no exception granted candidates from taking as the first case the Clinic case. If a candidate has financial hardship, the Director of the Institute will appoint a committee to discuss the matter and help the candidate find some financial solution without interfering with the policy of the Clinic case.
- (b) A letter was read from Eveoleen Rexford stating that to the best of her knowledge, there was no definition of the term "senior training analyst."
- (c) Dr. Van der Heide once more reminded the Chairman of the Education Committee that some decision should be reached about the Waelder lecture. This was noted and the Chairman of the Education Committee will attempt to report on this matter at the next meeting.
- (d) It was suggested by Dr. Kupper that at the next Education Committee meeting we discuss the possibility of approaching potential new training analysts.

- (b) Dr. Brunswick reported on the satisfactory performance of Dr. Donald J. Perry in Colloquium I. There was some discussion about the difficulty in framing psychoanalytic questions so as to avoid either obscurity or trickiness.
- (c) The situation of Dr. Seymour Friedman, who requested permission to enter the specialized child analysis training program, was discussed. The Education Committee felt he should not begin any child analysis until he has one adult case well under way in supervision. He is given permission, however, to attend lectures and seminars on child analysis. Dr. Friedman will be informed of this.
- (d) Dr. Rita Spies was given permission to limit her seminar work due to the pressure of her family life at this time.

- (e) Dr. James Grotstein's request for a third case in supervision was granted.
- (f) Dr. Fenichel announced the interruption--termination of Dr. Kenneth Rubin's personal analysis on August 1st.
- (g) The Education Committee felt that a seminar at Reiss-Davis Clinic on supervision of child psychotherapy should be watched by the members in order to ascertain whether there are interferences in the training of psychoanalytic candidates.
- 5. Curriculum: After much discussion, the Education Committee decided to abandon the policy of instituting daytime seminars after this trimester. It was felt that daytime seminars interfere with the personal analysis schedule of the candidates and of the training analysts. Furthermore, the rigid limitations of time imposed by a daytime seminar schedule interfere with the best educational atmosphere. Finally, it was not noted that there was any change in the responsiveness or alerthess of the candidates in the daytime. If an instructor wishes to arrange for daytime seminars and if the candidates of his class can arrange it, this may be done on an individual basis. The candidates will be informed of this decision.

6. Guest Lecturers:

- (a) Dr. Friedman reported about having found a suitable place for the Anna Freud lectures at the Women's Club of Pacific Palisades. The next step is to ascertain the dates of her arrival.
- (b) Dr. Max Schur will be invited to give two evenings on anxiety and phobias in the late Fall or Winter.
- (c) Dr. Phyllis Greenacre is to lecture in San Francisco in March and will be asked by the Society to speak here.
- (d) The Society has invited Robert Cohen to speak in Los Angeles in February.
- (e) The Education Committee voted in favor of having three lectures or seminars on Ego Psychology during this academic year. Dr. David Rapaport will be consulted by the Chairman of the Education Committee concerning the choice of lecturer between Dr. Roy Shafer and Dr. Stewart Miller.

7. Report of Board on Professional Standards:

Dr. Van der Heide and Dr. Greenson gave a brief summary of the last meeting of the Board on Professional Standards. The essential points concerned the report of the Survey Committee and the eventual appointment of a Director of Education for the American Psychoanalytic Association.

8. New Business:

- (a) The Education Committee, in general, approved of the Bulletin of the Training School of 1958-1959. Dr. Van der Heide made some suggestions about the grammatical errors which he will write to Mrs. Yerkes. The Education Committee members will inform Mrs. Yerkes of any other suggestions and changes for the next Bulletin.
- (b) Dr. Greenson reported on progress of the Manual for Psychoanalytic Candidates and the Education Committee suggested an addendum for the training analysts. It was decided by the Education Committee not to list the names of the candidates in the Manual.
- (c) Mrs. Yerkes is undertaking a survey of available time for new didactic analyses and new supervision for the academic year 1958-1959. She will report upon this at the next meeting. This is to better appraise the bottlenecks in our training program.
- (d) Dr. Brunswick moved, seconded by Dr. Van der Heide and unanimously accepted by the Education Committee that Dr. Friedman and Dr. Rangell were now eligible to be supervising analysts.
- (e) There was some discussion by Dr. Lewy about whether the Education Committee should write to the Membership Committee of the American about certain applicants for membership. It was decided that this best be done on an individual basis.
- (f) Dr. Lewy suggested in the future the minutes of the meeting should contain the names of persons who make proposals and motions. This was agreed upon in principle.
- (g) The next meeting of the Education Committee will be October 2, 1958.

The meeting was adjourned at 9:30 P.M.
