THE PSYCHOANALYTIC STUDY GROUP OF LOS ANGELES

Ammendment to By-Laws

To be voted on 25 January 1952

Add: Article VIII

- (1) The Psychoanalytic Study Group of Los Angeles shall become a part of the Extension Division of the Los Angeles Institute for Psychoanalysis under the name of "Study Group of the Los Angeles Institute for Psychoanalysis (Extension Division)".
- (2) Pursuant to this aim, the above By-Laws of the Study Group are hereby repealed, so that the Study Group shall function according to the By-Laws of the Los Angeles Institute for Psychoanalysis, and in the Extension Division of said Institute, which is organized by the Director of the Extension Division, subject to approval by the Director of the Institute and the Professional Committee of the Institute.
- (3) It is the wish of the Study Group that its functions as a study and discussion group shall be administered by a Program Committee of four, three of whom, including a Chairman, shall be elected by those Members and Scientific Associates of the Institute who are active in the Study Group, and the fourth shall be the Director of the Extension Division ex-officio.

THE PSYCHOANALYTIC STUDY GROUP OF LOS ANGRIES. Ammendment to By-Lawa To be voted on 25 January 1952 Add: Article VIII

- (1) The Psychosnalytic Study Group of Los Angeles shall become a part of the Extension Division of the los Angeles Institute for Psychosnalysis' under the name of "Etudy Troup of the Los Angeles Institute for Psychosnalysis (Extension Davision)".
- (2) Pursuant to this aim, the above Declove of the Study Group Study Group are highly repealed, so that the Study Group shall function according to the Dy-laws of the los Angeles Institute for Psychosnalysis, and in the Extension Division of said Institute; which is organized by the Director of the Extension Division; subject to approval by the Director of the Institute and the Professional Committee of the Institute.

- (4) Those of the present Members, Associate Members and Permanent Guests of the Study Group who are not at present Members of the Los Angeles Institute for Psychoanalysis shall become Associate Members (Scientific Associates, or Affiliates) of said Institute, subject to election by the Board of Trustees of said Institute, with dues for such memberships to be set by the Institute at levels no higher at the present time than have been paid in the Study Group most recently.
- (5) Financial management and secretarial operations of the Study Group shall become functions of the Los Angeles Institute for Psychoanalysis (though they may be duly delegated).
- (6) The Otto Fenichel Memorial Library of the Psychoanalytic Study Group of Los Angeles shall become part of the Library of the Los Angeles Institute for Psychoanalysis, with the exception of such books and journals as may be of special interest to the School for Nursery Years, to which these shall be donated. It is the wish of the Study Group that the Library of the Institute shall henceforth be known as the Ernst Simmel and Otto Fenichel Memorial Library (this of course subject to the approval of the Trustees of the Institute). The Library of the Institute will be open to use by all classes of members of the Institute, subject to the regulations of the Institute.
- (7) Funds of the Study Group previously earmarked for the School for Nursery Years should be paid over to said School; and the Los Angeles Institute for Psychoanalysis has already guaran-
