Minutes of the Meeting

1. The minutes of the meeting of June 20, 1963, were approved as distributed.

2. Membership Committee:

Drs. Schoenberger and Siegel were unanimously elected to Active Membership in the Society. Dr. Tausend announced the application for Active Membership of Dr. Leonard Gilman.

3. <u>Committee for Postgraduate Education:</u>

The report of this Committee's work was made by Dr. Samuel Sperling in the absence of Dr. Robert Stoller, Chairman. The Committee will proceed with the following two postgraduate seminars:

- a. A luncheon seminar, chaired by Dr. Michael Rosow, which will provide an opportunity to discuss therapeutic problems in psychoanalysis.
- b. The seminar on the Philosophy of Scientific Methodology will be continued with Dr. Richfield as the seminar leader. Dr. Richfield will be reimbursed \$500 for the seminar series; the Society will contribute one-half of the amount, and the participants of the seminar will contribute the other half. A proposal that \$250 be appropriated from the Society for this seminar was passed. It was noted that ten members to date have indicated an interest in this seminar. Others interested are requested to contact Dr. Stoller.

From time to time qualified people will be asked to present seminars on various subjects. Arrangements have been made with Dr. Sidney Tarachow to offer a seminar on psychotherapy on Saturday, November 23, 1963, between 9- and 11 a.m. at the Institute auditorium.

Dr. Stoller also suggested that \$300 be appropriated for further honoraria. A motion that \$300 be appropriated for this purpose was carried.

4. Announcements:

a. Committee on Social Issues:

Dr. Michael Rosow, who has been a consultant to the County Parole Clinic, will lead an informal discussion on the treatment of offenders on an out-patient basis using applied psychoanalytic techniques. This will take place on October 29, 1963, at 8 p.m. at the Institute.

b. Dr. Samuel Futterman announced that the Pan-American Congress will be held in Acapulco on March 2 and 3, 1964, and in Mexico City, March 4 to 7, 1964. Further

information will be made available to Society members and candidates. Travel information was discussed by Dr. Futterman, who stated that details clarifying this situation will be forthcoming.

- c. A Latin American Psychoanalytic Societies meeting is scheduled in Mexico City, extending from February 24 to 28, 1964, just before the Pan-American Congress.
- d. Dr. Mandel announced that another meeting will be held in Mexico City by the American Psychiatric Association sometime in May, 1964.
- e. UCLA Medical School is offering an Extension Division course in internal medicine extending from February 26 to March 7, 1964.
- f. Dr. Sperling stated that the tentative location for the West Coast Psychoanalytic Societies Meeting was San Diego sometime in October, 1964. This meeting will not be held in conjunction with the Psychiatric Association.
- g. Dr. William Horowitz, Co-Chairman of the Committee for the Study of Psychoanalytic Practice, gave a brief survey of what has been done to study psychoanalytic practice locally. In the near future the members of the Society will be solicited in a mailed survey from this Committee.

The meeting was adjourned at 8 p.m.
