4. Announcements:

- a. Dr. Futterman announced the following:
 - 1) The minutes of the Annual Meeting of The American Psychoanalytic Association will be covered at the June meeting of the Society. A special committee will be appointed to report on the work of the Committee on Organization and Planning of The American Psychoanalytic Association.
 - 2) There are notes on the bulletin board in the Society office from Drs. Mott and Leavitt expressing their appreciation for our interest in recent illnesses.
 - 3) There has been a meager response (10% thus far) to the solicitation for insurance application, despite the show of interest manifested in the number of hands raised at the meeting. This is in a way a "family affair" which makes it possible for otherwise uninsurable members to obtain coverage. (Dr. Sarlin did not understand that action was expected in response to the mailing and regarded it purely as informational. He felt that a letter of clarification would help.)
 - 4) Dr. Norman Atkins and Dr. Sidney Z. Hulbert were elected to membership in The American Psychoanalytic Association.
 - 5) Dr. Rudolf Ekstein's appointment as training analyst was confirmed by the Board on Professional Standards of The American Psychoanalytic Association.
 - 6) The Executive Council of The American Psychoanalytic Association passed a resolution on the social-issues question that went further than our own statement.
- b. Dr. Horowitz reported for the Adjunct Committee on the History of the Society that photographing of members will be started in groups of six, covering the next six months. Appointments will be made. There will be no charge for the photographs, and there is no obligation on the part of the members.
