

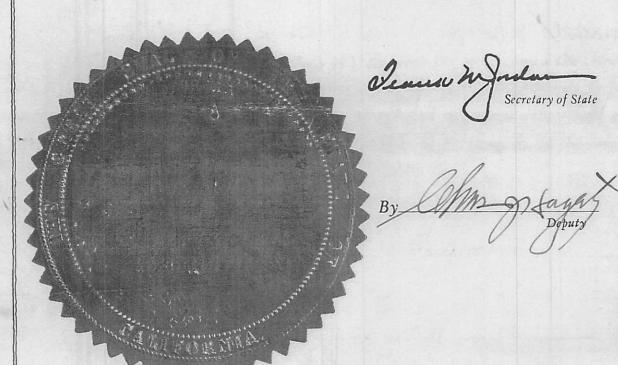

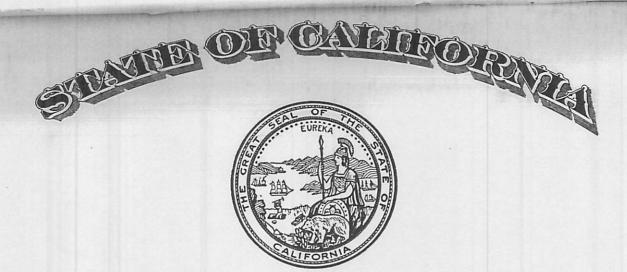

CERTIFICATE OF AMENDMENT

OF ARTICLES OF INCORPORATION PRANK M. JORDAN, Secretary of State By F. C. VOGEL

LOS ANGELES INSTITUTE FOR PSYCHOANALYSIS Deputy

The undersigned, DR. MAIMON LEAVITT and DR. ARTHUR OURIEFF, do hereby certify that they now are and at all times herein mentioned have been President and Secretary, respectively, of LOS ANGELES INSTITUTE FOR PSYCHOANALYSIS, a non-profit, nonstock California corporation, and further they do hereby certify as follows:

1. At a special meeting of the Board of Directors held on January 26, 1967, at 10:00 A.M., at 344 North Bedford Drive, Beverly Hills, California, the following resolutions were duly adopted:

> RESOLVED: That Article 1. of the Articles of Incorporation of this corporation be and it hereby is amended to read as follows, in full:

"1. The name of this corporation is Los Angeles Psychoanalytic Society and Institute. '

RESOLVED FURTHER: That the following matter be and it hereby is added to the Articles and designated Article 7 .:

- "7. The property of this non-profit corporation is irrevocably dedicated to scientific and educational purposes and on dissolution none of its assets shall inure to any individual, but shall be distributed to a fund or foundation whose property is dedicated to exempt purposes as specified in Revenue and Taxation Code Section 214.
- 2. At a special meeting of the voting members of the corporation held on the second day of March, 1961, at 10:00 A.M., at 344 North Bedford Drive, Beverly Hills, California, the foregoing Amendments to the Articles of Incorporation were ratified and approved by a resolution identical in form to said Directors' resolution '

set forth in Paragraph 1 of this Certificate.

- 3. The number of members voting in favor of the above resolutions was 116 members.
 - 4. The total membership entitled to vote is 114 members.
