(b) The Education Committee decided to have regular meetings primarily for the purpose of discussing candidates individually. These meetings will be held approximately every two months.

5. Manual for Training Analysts:

- (a) There was further discussion about the procedure for the appointment of Training Analysts. Dr. Lewy suggested that the factor of therapeutic skill should be inserted into the qualifications. It was further suggested that at least two supervising analysts should have the occasion to supervise the work of the prospective Training Analyst. An additional element will be added to the procedure by inserting the statement that the Education Committee will consider it highly desirable that a prospective Training Analyst should have some additional analysis between the time of graduation and appointment to Training Analyst, preferably with an analyst other than his original Training Analyst. The finalized version of this procedure will be distributed to the Education Committee and also to all members of the Institute for their information.
- 6. Board on Professional Standards:

 (a) Dr. Greenson and Dr. Van der Heide or Dr. Friedman were elected to be Fellows to the Board on Professional Standards at the Midwinter Meeting. If Dr. Van der Heide is unable to go to the meeting, Dr. Friedman will be the Fellow.
- 7. It was announced that Dr. Gottfried Bloch and Dr. Frances Cottington have applied for membership in the Los Angeles Psychoanalytic Society. This will be discussed by the Education Committee as soon as we have sufficient information about their training.
- 8. Dr. Friedman brought up the possibility of inviting Dr. Augusta Bonnard as guest lecturer in September, 1960. The Chairman of the Education Committee will write to her to see whether she has material suitable for the candidates, and if so, this matter will be discussed again.

MINUTES OF THE MEETING

The following members of the Education Committee were present: Mrs. Deri, Drs. Fenichel, Friedman, Greenson, Lewy, Rangell, Van der Heide, and Vatz.

1. The minutes of the meeting of June 4, 1959 were accepted as distributed.

2. Admissions Committee:

- (a) Drs. Evans and Rangell have completed their tour of duty on the Admissions Committee. Since Dr. Vatz is leaving town for a prolonged period, it is therefore necessary to replace three members of the Admissions Committee. Drs. Van der Heide, Jokl and McGuire will be asked to serve on the Admissions Committee, in addition to Drs. Fenichel and Friedman.
- (b) The Admissions Committee meeting to discuss new applicants prior to the next Education Committee meeting will be held Wednesday, October 7th at 1:00 P.M. at the Institute.
- (c) The application of Dr. Donald T. Fullerton was discussed and it was recommended and approved that he be accepted for psychoanalytic training.
- (d) Dr. Bonnett replied to our question about the processing of psychiatric residents during their first year of residency. It was her suggestion and the Education Committee agrees, that we present a resolution at the next Board of Professional Standards meeting stating that the applications of psychiatric residents should not be processed until they have completed one year of psychiatric residency.

3. Candidates:

- (a) Dr. Greenson reported about the orientation meeting with the candidates.
- (b) The situation of Dr. Carolyn Hays was briefly discussed. It was recommended that she begin personal analysis with a Training Analyst as soon as possible. Further, she should be advised to limit her therapeutic work with patients to psychotherapy and to conclude as soon as possible her work under supervision with a Training Analyst. Finally, she will be told that attendance in seminars will have to wait until we are better aware of her academic situation.

- (c) Dr. Norman Atkins' request for Colloquium II was discussed and approved. Drs. Fenichel and Lewy will be the examiners.
- (d) Dr. Sidney Hulbert's request for Colloquium II was discussed and approved. Drs. Friedman and Rangell will be the examiners.
- (e) Dr. Donald Perry's request for a second psychoanalytic case under supervision was approved.

4. New Publications:

- (a) There were several errors in the various publications of the Institute pointed out by the Education Committee. If further errors are discovered, please bring this to the attention of the Chairman.
- (b) Final discussion of the Manual for Training Analysts will begin at the next meeting of the Education Committee.

5. Curriculum Committee:

- (a) There was some discussion about the complications of teaching seminars in which one's own candidates are present. Our conclusion was that this is regrettable but unavoidable.
- (b) Dr. Hanna Fenichel, representing the Curriculum Committee, reminded the Faculty members that bibliography and syllabus should be prepared as soon as possible for distribution to the candidates.

6. Faculty Committee:

(a) In reply to our question, Dr. Bonnett wrote stating that in her opinion, Dr. Ekstein could be appointed to the Faculty of the Institute without Board approval. She was going to write Dr. Morse for confirmation. It was the opinion of the Education Committee that Dr. Bonnett was in error. It was suggested that the Chairman write Dr. Morse about this question in order to receive a prompt reply.

7. Clinic Committee:

- (a) Dr. Friedman stressed the need for control hours being made available to the candidates and suggested that supervision of members should be curtailed in favor of making this time available for the candidates.
- (b) Pursuant to the suggestion of Dr. Lihn, Director of the Clinic, there was some discussion of establishing the fee for supervisors of Clinic cases at \$20 per hour. This was moved and accepted and will be presented to the Professional Committee for further action.

8. Report of the International Congress:

Drs. Rangell and Lewy reported briefly on the meeting with Melanie Klein. Drs. Friedman and Greenson reported briefly on some of the business transactions of the International. It was agreed that it would be beneficial to have a scientific discussion concerning the validity of the ideas of the so-called "Kleinian" school.

9. Guest Lecturers:

- (a) It was reported that Dr. Gero is unable to appear as a guest lecturer this Fall but might be able to do so in the Spring.
- (b) It was decided to invite Erik Erikson and John Benjamin as guest lecturers during the academic year.

10. New Business:

(a) Dr. Tidd's suggestion for the recording of the history of the Los Angeles Institute and Society was discussed. Dr. Brunswick will be informed and he and Dr. Friedman will appoint a committee to pursue this objective.

The meeting was adjourned at 10:25 P.M.
