#### MINUTES OF THE MEETING

All members of the Education Committee were present except Drs. Evans, Jokl and Tidd.

- 1. The minutes of the meeting of March 5, 1959 were corrected as follows:
  - (a) Item 2: Correct first sentence to read: "The following recommendations were made by the Admissions Committee and accepted by the Education Committee." (Greenson)
  - (b) Item 3(e): Correct to read: "There was some discussion about the work of Dr. James Grotstein and it was the consensus that he showed definite improvement." (Van der Heide)
  - (c) It was suggested that the Minutes of the Education Committee Meetings should be signed by Dr. Greenson, Chairman. (Brunswick)

The minutes were then approved as corrected.

#### 2. Admissions Committee:

- (a) The Admissions Committee Committee made the following recommendations:
  - (1) The application of Dr. Ernest Arons to be accepted.
  - (2) The application of Dr. Barton Lee Fischer to be accepted.
- (3) The application of Dr. Carolyn Hayes Bail to be accepted under the condition that she agree to the following:
- a. To make arrangements to begin personal analysis with an experienced Training Analyst as soon as feasible.
- b. To accept indeterminate status as a candidate in the Institute until the Education Committee has had ample opportunity to evaluate her training status.
- c. To accept no new analytic patients until given permission by the Education Committee.

These recommendations were approved by the Education Committee.

- (b) Drs. Lewy and McGuire completed their tour of duty on the Admissions Committee and will be replaced by Drs. Fenichel and Friedman.
- (c) In discussing the processing of applicants, it was concluded that at present under the policies of the Board on Professional Standards, an applicant may be processed before he has completed one year of psychiatric residency. However, training may not begin before he has completed that year. The Fellows to the Board on Professional Standards were advised to suggest stipulating in this provision that processing should not begin until an applicant has completed nine months of psychiatric residency in order to insure some knowledge about his reactions to work with psychiatric patients. The Institute for Psychoanalytic Medicine of Southern California will be informed that for the time being, our policy will be to accept applications before the completion of one year of training, etc.
- 3. <u>Candidates</u>: The following actions were approved by the Education Committee:
  - (a) Dr. Marshall Schechter's request for graduation.
  - (b) Dr. Elaine Pollit's request for graduation.
  - (c) Dr. Bernard Bail's request for Colloquium II. Dr. Brunswick and Dr. Lewy will be the examiners.
    - (d) Dr. Genevieve Stewart's request for a 2nd supervised case.
    - (e) Dr. William Horowitz's request for a 2nd unsupervised case.

# 4. Board on Professional Standards - APsaA:

- (a) Dr. Carel Van der Heide was appointed a Fellow to the Board on Professional Standards for this meeting to replace Dr. Ralph Greenson, who is not attending. The Board on Professional Standards will be so informed. Dr. Leo Rangell is the other Fellow to the Board.
- (b) There was some discussion about instructions to the Fellows concerning the Board of Psychoanalysis. In principle, the Los Angeles Institute is in opposition to the formation of a Board. However, since it is felt that such a move is inevitable, our Fellows were instructed to try to assure the fact that members of the American Psychoanalytic Association will be in control of the Board of Psychoanalysis. It was hoped that a provision will be made requiring Psychoanalysis. It was hoped that a provision will be made requiring that appointments to the certifying board must include the fact that the appointee has worked in the field of psychoanalysis and has not been anti-analytic. It is further hoped that before such a Board of Psychoanalysis is established, the details of the structure and functions of such a Board will be distributed to the local Institutes for discussion and suggestions.

# 5. Training Analysts:

(a) There was a brief discussion about the proposed procedures for reappointment of Training Analysts. These procedures were tentatively accepted as part of the policy in the form which they were distributed to the Training Analysts. Final decision will be made when the Manual for Training Analysts will be voted upon.

# 6. Faculty:

- (a) In principle, the proposals concerning the structure and function of the Faculty Committee were approved by the Education Committee.

  Dr. Van der Heide pointed out that new instructors are appointed for a series of seminars and not for a given period of time. This will be corrected in the proposal and will be submitted once more for final action when the entire Manual has been completed.
- (b) Dr. Rangell reported on the work of three prospective teachers in the Institute. He found Dr. Henry Lihn sufficiently advanced to be assigned a course in the future. Dr. Bernard Brandchaft and Dr. Jerome Shiell should have additional experience in leading a seminar for an evening before appointment as instructors. These recommendations were accepted by the Education Committee.

#### 7. Child Analysis Program:

(a) Five candidates indicated interest in the Child Analysis Program. They are Drs. Call, Siegel, Stewart, Unger and Weaver. Further discussion will be held with Mrs. Ruben to see whether it is feasible to arrange for seminars to begin in the Fall of 1959.

#### 8. Guest Lecturers:

- (a) It was reported that Anna Freud stated that she could tell the difference between the two Institutes by the way the various discussants asked their questions.
  - (b) The Education Committee was not in favor of Dr. Gero's wish to have his lectures on a weekend. His request for postponement was granted. He will be so informed.

#### 9. New Business:

- (a) The revision of the By-Laws of the American Psychoanalytic Association was briefly discussed by Dr. Brunswick and it was found that in general, our opinion was favorable.
- (b) Dr. Brunswick was selected to represent the Los Angeles Institute in the discussion of de Saussure's paper at the International Congress in Copenhagen.
- (c) The Education Committee approved of Dr. McGuire's request that his seminar and the seminar of Dr. Friedman be consolidated with Dr. Friedman conducting the seminar, since numerically it was advantageous.

The meeting was adjourned at 10:00 P.M.

# PROPOSED PROCEDURE FOR REAPPOINTMENT OF TRAINING ANALYSTS

- 1. Reappointment to Training Analyst status is to be decided by a majority vote of those Training Analysts present, but proxies will be valid.
- 2. Reappointment is for a period of five years.
- 3. No vote shall be taken until the Training Analyst under discussion has come up for consideration in at least two different meetings.
  - (a) In the first meeting, the Training Analyst under discussion shall be absent.
  - (b) If it is deemed advisable, a special committee will be appointed by the Chairman of the Education Committee after the first meeting in order to obtain and present information at the subsequent meetings.
  - (c) In the subsequent meetings, the Training Analyst under discussion shall be present in order to answer whatever questions may have arisen concerning his reappointment.
- 4. Voting shall be by secret ballot.
- 5. Reappointment as a Supervising Analyst will be considered automatically when Training Analyst status is up for decision, provided he is already a Supervising Analyst.
- 6. If a Training Analyst is not reappointed, arrangements will be made to protect the candidates from being penalized by the discontinuation of the appointment.

# PROPOSED STRUCTURE AND FUNCTION OF THE FACULTY COMMITTEE

# . STRUCTURE

- 1. The Faculty Committee shall consist of:
  - (a) Chairman, a Training Analyst, who has been active on the Faculty and in the Training School
  - (b) One member of the Curriculum Committee
  - (c) One instructor who is a non-Training Analyst
  - (d) One unofficial member, a senior candidate, who will be a representative of the Candidates.

# . FUNCTIONS:

- 1. The evaluation of teaching performances
  - (a) At regular intervals, this Committee should ascertain the caliber of the teaching by questionnaires and other methods.
  - (b) The Faculty Committee should meet at least once per year with the candidates in person.
- 2. Selection of teaching personnel
  - (a) To consider applications from Institute members who might be interested in becoming instructors.
  - (b) To select and invite Institute members who might be potentially good teachers.
    - (1) All new appointments as instructors in the Institute shall be for one year and successive appointments for a period of two years, subject to the majority confirmation of the Education Committee.
  - (c) To suggest guest lecturers, etc.
  - (d) In cooperation with the Curriculum Committee select the lecturers and seminar leaders for the curriculum of the Los Angeles Institute for Psychoanalysis.
- 3. To suggest procedures for the training of new instructors.
- 4. To suggest procedures for improving the teaching by appointed instructors.
- 5. To arrange for regular meetings of the Faculty
  - (a) To discuss problems of teaching with the Faculty
  - (b) To meet with the Curriculum Committee and exchange ideas.
