The following is a report of the activities of the Los Angeles Institute for Psychoanalysis for the fiscal year June 1, 1964 - May 31, 1965.

At the last Annual Meeting, June 11, 1964, the following officers were elected:

Mr. Walter Hilborn, President, Maimon Leavitt, M.D., Secretary,
Leonard M. Rosengarten, M.D., Treasurer.

On August 4, 1964, a special meeting of the Professional Committee was held. All training analysts were invited to attend this meeting. The order of business was essentially a consideration of the report of the Committee on Institutes following their April visit to our Institute. Because of the importance of the report and the issues involved, it was felt best to have the meeting at this time rather than wait until the Fall.

The Professional Committee decided that the report should be sent to the Joint Committee on Mutual Problems for their consideration and be made available to all members of the Institute.

On April 6, 1965, the Board of Trustees passed the following amendment to the By-Laws:

ARTICLE VIII - Organization of the Divisions of the Institute

Section 1 - The Training School:

"The Training School of the Institute shall be expressly managed by the Education Committee. Training Analysts under the age of seventy shall constitute the Education Committee."

This change is not retroactive.

Dr. Hanna Fenichel was appointed a member of the Committee to Study Reorganization of the Institute and also to be a member of the Joint Committee on Mutual Problems of the Institute and Society.

I am sorry to report to you that Dr. Lawrence J. Friedman has resigned as Chairman of the Education Committee and Dean of the Training School, effective June 3, 1965. He has served in this capacity for the past four years.

Dr. Friedman has been an important and influential part in the development and growth of the Institute and Society. Since 1952, he has served in the following capacities:

During his term of office as Dean, he has presented and been responsible for many changes. His most recent interest has been the reorganization of the Institute, Society and Education Committee.

His suggestions have far reaching consequences and are of great importance. Some of these changes have already been put into effect, others at the present time are being studied by the Joint Committee on Mutual Problems. I am sure that many of his proposals will be incorporated in the recommendations of this committee. Dr. Friedman has been devoted to the affairs of the Institute and his resignation has been accepted with regret by the Education Committee and the Board of Trustees.

At the last meeting of the Education Committee, Dr. Henry Lihn was elected Dean of the Training School and Chairman of the Education Committee to fill Dr. Friedman's unexpired term, 1965-1966.

Guest speakers invited to speak to the candidates during the past academic year included Dr. Lothar Rubinstein and Dr. Herbert Rosenfeld, both of London.

We are one of the first Institutes to set up an effective retirement policy for Training Analysts. We have followed the guidelines recommended to the Board on Professional Standards, modified to fit our own needs.

The following retirement procedures were adopted by the Education Committee on June 3, 1965:

During the past year, major changes were made in regard to candidate participation in the treatment of Clinic cases. The requirement that all candidates must treat in analysis at least one Clinic case was modified. It is now on a voluntary basis and the pledge to treat Clinic cases is no longer required.

It was also decided that a candidate with a Clinic case in treatment at that time should have the option either to turn over the fee to the Clinic and continue to receive supervision without charge, or, to elect to retain the fee and make arrangements for supervision of the case on a private basis. The above changes became effective December 1, 1964 for a trial period of one year.

Another major change, approved April 1965, extends the activities of the Psychoanalytic Clinic to give treatment to selected cases which are not accepted for psychoanalysis.

These new procedures met with the instant approval of the candidates and members of the Institute and Society. As a consequence of this, the Psychoanalytic Clinic has received generous gifts which I will refer to later in this report.

EXTENSION DIVISION

Hilda S. Rollman-Branch, M.D., Director

This is the second year that Dr. Hilda S. Rollman-Branch has been Director of the Extension Division and from the schedule of events listed, it becomes obvious that this Division of the Institute keeps growing and has become important and influential in the dissemination of psychoanalytic knowledge to other professions, e.g., social workers, probation officers, psychiatrists, psychiatric residents, teachers, school psychologists, educators, attorneys and judges.

To give you some idea of the increased interest manifested by these groups, last year the attendance at the all-day conference for social workers was 63 and this year 149. The demand was so great we had to limit the number we could accommodate. In addition to this, we added three seminars for social workers. Two seminars consisted of six lecture-discussion sessions and one seminar for psychiatric social workers consisted of eight sessions.

The Extension Division in conjunction with the Reiss-Davis Clinic and the Center for Early Education, an accredited California college, continued their program for teachers, school administrators, school psychologists and pupil personnel workers.

This is the first year that the University of California at Santa Barbara has joined the teachers program given by the Extension Division of the Los Angeles Institute for Psychoanalysis and the Reiss-Davis Clinic. This program consisted of ten sessions and was given in Oxnard, California. Teachers who attended the above programs received two units of credit for each course.
