SUBJECT: A Systematic Attempt at Validation of the Hypothesis of Preconscious Perceptual Registration (The Poetzl Phenomenon).

Dr. Rangell indicated that these reports would now be a regular procedure in Society meetings. Dr. Greenson reported that Drs. Bruce Christianson, Richard Edelman and David Thiele have been accepted for training. He also mentioned that the following five candidates have passed Colloquium: Drs. Gilman, Grotstein, Malin, Mott and Spies. Dr. Greenson invited questions of the membership.

New Business

Dr. Dorn asked that members interested in working with the Beverly Hills Chapter of the Los Angeles County Medical Society on the subject of Mental Health get in touch with him.

Dr. Rangell mentioned that the Mental Health Foundation had available some funds for persons interested in any type of research.

Dr. Sperling of the Program Committee stated that his Committee was available for suggestions about presentation of papers.

During the summer, Dr. Rangell appointed all committees and members of the selected committees were so notified and are functioning. The list is available for anyone interested to see it.
